**ACTION ITEMS:**

Roll call: Supervisor Boogren – abstain, Clerk Borrett – yes, Treasurer Kevern – yes, Trustee Heikkila – yes, Trustee Bodenus - yes. Motion carried.

**Confirm Appointment of Planning Commission Member (9b.):** Motion by Borrett, supported by Kevern, to confirm appointing Ross Underwood to the Planning Commission. Supervisor Boogren thanked Ross Underwood for applying to the position. Roll call: Trustee Bodenus – yes, Trustee Heikkala – yes, Clerk Borrett – yes, Treasurer Kevern – yes, Supervisor Boogren – yes. Motion carried.

**FD – Relief Valve (9c.):** Motion by Boogren, supported by Bodenus, to approve purchasing a relief valve for \$2,000, as requested. Supervisor Boogren explained the purpose of the valve. **Pursue 425 Agreement with West Branch for Invader Street Property (9k.):** Motion by Boogren, supported by Kevern, to approve pursuing a 425 Agreement with West Branch for the property specified on Invader Street. Supervisor Boogren explained half of a building is in Forsyth and half in West Branch. Roll call: Treasurer Kevern – yes, Supervisor Boogren – yes, Trustee Heikkala – yes, Trustee Bodenus – yes, Clerk Borrett – yes. Motion carried.

**Marihuana Facilities (10a.):** Clerk Borrett stated she will email Board Members a copy of a draft ordinance. She proposed it will be finished soon.

**Review Fire Department Connection Ordinance (10b.):** Supervisor Boogren asked if anyone had any questions. It was the consensus of the Board to note that the ordinance has been reviewed and no changes are needed.

**Ballfield/Racetrack Project (10c.):** Trustee Bodenus questioned the status of the brush piles near the ice track. Treasurer Kevern explained the berms are needed for safety and sound, but will be cleaned up and planted on. Supervisor Boogren stated MJ VanDamme will be donating dust control for the ballfield road. Superintendent of Public Works Jancsi will verify the use in proximity to the water tower.

**Public Comment:** Adam Cournaya commented on the Marihuana Ordinance. Ron Lauren thanked Supervisor Boogren.
