Supervisor Kevern called the meeting to order at 4:04 p.m.

Mr. Anderson then asked Mr. Back to highlight accomplishments that were in addition to his resume. Mr. Back explained the additional accomplishments. Mr. Anderson asked candidate Jeff Thornton to join the meeting. At 6:39pm Mr. Thornton introduced himself and stated he had revisited areas within the township to see how things had changed.
