**Section 9.2 Rates, Fees and Charges for Sewer Service**

- 1) Monthly Base Rate Water Service Charge  
**\$45**/month (0 to 2,000 gallons of consumption)
  
- 2) Water Consumption Charge  
**\$18.00** / 1,000 gallons of water consumption, pro rata
  
- 3) Readiness to Serve Charge  
**\$30**/month **per base rate**, water shut off at curb stop
  
- 4) Debt Service Charge  
None
  
- 5) Water Connection Charge  
\$500  
  
Reconnect Fee (Vacant land with a new structure that has a PIT already installed)  
\$250
  
- 6) Turn On/Off Fees  
Summer (April 2 – October 31) \$20  
Winter (Nov 1 – April 1) \$50
  
- 7) New or Replacement Connection to the System  
Permit Fee \$25  
Tap Charges Time and Materials as determined by Forsyth Township Staff
  
- 8) Outside Service  
None
  
- 9) Bulk Water Fee  
\$18 per 1,000 gallons of use

- 10) Hydrant Rental Fee  
\$20,000 for system wide hydrant rental

\$100

\$35
- d) Water Restoration Charge  
\$100

**Section 11 Additional Provisions**

- a) Water Base Rate  
\$45/month (0 to 2,000 gallons of consumption)
- b) Deposit to begin new service for blacktop cut and roadway repair \$750  
If less than \$750, remainder will be returned to user. If more than \$750, user will be billed for balance.
- d) Summer Meter  
Installation, Use and Removal Fee \$30  
Rental Fee \$10/month  
Replacement Cost \$125
- e) Meter Pull  
¾" and 1" Meters - \$30, Plus the cost of turning off the curb stop  
1 ½" and 2" Meters - \$100, Plus the cost of turning off the curb stop  
3" or larger Meters - \$300, Plus the cost of turning off the curb stop
- f) Meter Replacement  
Time and Materials as determined by Forsyth Township Staff

- i) Tampering Fine  
\$250
