Michigan, shall the total amount of ad valorem taxes collected be renewed at and increased up to the previously authorized six tenths (.6) of a mill (\$0.60 per \$1,000 of Taxable Valuation of real and taxable personal property), of which .5887 mill is a renewal of the previously authorized millage and .0113 mill is a new additional millage, for a period of (6) years, from 2027 through 2032 inclusive.

County Proposition – Veterans Affairs Millage Shall Marquette County levy a millage of 0.0500 mill (\$0.05 per \$1,000 of taxable value) for the years 2027 through 2035 inclusive, as authorized by MCL 35.21, for the purpose of improving and expanding services for veterans, including outreach, access to benefits and healthcare, support for veterans facing mental health challenges, rural service delivery, transportation coordination, and countywide services provided by the Marquette County Department of Veterans Affairs?

Forsyth Township – General Operating Millage Renewal Shall the previously-voted increase in the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution in Forsyth Township of 4.8751 mills (\$4.8751 per \$1,000 of taxable value), which expires after 2026, be renewed and authorized at the same rate of 4.8751 mills for seven (7) additional years, 2027 through 2033, inclusive, for Forsyth Township’s general operating purposes, raising an estimated \$1,266,215.37 in the first year the millage is levied?

Forsyth Township – Library Services Millage Renewal Shall the previously-voted increase in the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution in Forsyth Township of 0.4947 mills (49.47 cents per \$1,000 of taxable value), which expires after 2026, be renewed and authorized to the same rate of 0.4947 mills for seven (7) additional years, 2027 through 2033, inclusive, for Forsyth Township’s library services, raising an estimated \$128,489.00 in the first year the millage is levied?

Forsyth Township – Police Services Millage Renewal Shall the previously-voted increase in the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution in Forsyth Township of 0.9965 mills (\$0.9965 per \$1,000 of taxable value), which expires after 2026, be renewed and authorized to the same rate of 0.9965 mills for seven (7) additional years, 2027 through 2033, inclusive, for Forsyth Township’s police services, raising an estimated \$258,822.10 in the first year the millage is levied?

Humboldt Township – General Operating Millage Shall the expiring previous voted increase in the tax limitation imposed in Humboldt Township under Article IX, Sec. 6 of the Michigan Constitution of 3.0000 mills (\$3.00 per \$1,000 of taxable value), reduced to 2.9766 mills (\$2.9766 per \$1,000 of taxable value) by the required millage rollbacks, be renewed at and increased up to the original voted 3.0000 mills (\$3.00 per \$1,000 of taxable value) and levied for four (4) years, 2026-2029 inclusive, for the purpose of general operating, raising an estimated \$122,232.53 in the first year millage is levied.

Humboldt Township – Sanitation Millage Shall Humboldt Township levy a new millage of 1.0000 mills (\$1.00 per \$1,000 of taxable value) for three (3) years, 2027-2029, inclusive, for the purpose of providing sanitation services, raising an estimated \$40,744.18 in the first year the millage is levied?

Humboldt Township – Fire Protection Millage Shall Humboldt Township levy a new millage of 1.0000 mills (\$1.00 per \$1,000 of taxable value) for four (4) years, 2026-2029, inclusive, for the purpose of providing fire protection services, raising an estimated \$40,744.18 in the first year the millage is levied?

Humboldt Township – Emergency Services Millage Shall Humboldt Township levy a new millage of 0.2500 mills (\$1.00 per \$1,000 of taxable value) for four (4) years, 2026-2029, inclusive, for the purpose of providing emergency services, raising an estimated \$10,186.05 in the first year the millage is levied?

Michigamme Township - General Operating Millage Renewal Proposal Shall the expiring previous voted Michigamme Township increase in the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution, of 4.00 mills (\$4.00 per each \$1,000.00 of taxable value), reduced to 3.8457 mills (\$3.8457 per each \$1,000.00 of taxable value) by the required millage rollbacks, be renewed and levied for three (3) years, 2027 to 2029, both years inclusive, for general operating purposes including operation of sanitation, park, building and roads?

Marquette Charter Township – Emergency Medical Services Shall the authorized millage for the Charter Township of Marquette be increased by a new millage in an amount not to exceed 1.0 mill (\$1.00 for each \$1,000 of taxable property value) for one (1) year, only, in 2026, for the purpose of funding additional dedicated staffing for Emergency Medical Services (EMS) continuous coverage 24 hours per day, 7 days per week?

Richmond Township -Renewal for General Operating Shall the expiring previous voted increase in the tax limitations imposed under Article IX, Section 6 of the Michigan Constitution in Richmond Township, Marquette County, Michigan, of 2.5000 mill (\$2.50 per \$1,000.00 of taxable value of real and tangible personal property) reduced to 2.3915 (\$2.3915 per \$1,000.00 of taxable value) by the required millage rollbacks, be renewed at and increased up to the original voted 2.5000 (\$2.50 per \$1,000.00 of taxable value) for a period of five (5) years, from 2027 through 2031, both inclusive, for general operating purposes, raising an estimated \$80,000.00 in the first year the millage is levied.

Sands Township – Ambulance Operating Millage Renewal Shall the expired previous voted millage of one half mill (\$0.5000 on each \$1,000 of taxable value) as reduced by the required millage roll back which last resulted in a levy of 0.4349 mills (\$0.4349 on each \$1,000.00 of taxable value) against all property in Sands Township, Marquette County, Michigan be renewed at a rate of 0.4349 mills for a period of four (4) years, 2026 through 2029 inclusive, for the purpose of providing funds for equipment for the ambulance department?

Sands Township – Sanitation Operating Millage Renewal Shall the expired previous voted millage of one mill (\$1.0000 on each \$1,000.00 of taxable value), against all property in Sands Township, Marquette County, Michigan, be renewed at the original voted rate of 1.0000 mill for a period of four (4) years, 2026 through 2029 inclusive, for the purpose of providing funds for sanitation operating, disposal and equipment expenses within Sands Township?

Sands Township – Fire Department Operating Millage Renewal Shall the expired previous voted millage of one mill (\$1.0000 on each \$1,000 of taxable value) as reduced by the required millage roll back which last resulted in a levy of 0.8704 mills (\$0.8704 on each \$1,000.00 of taxable value) against all property in Sands Township, Marquette County, Michigan be renewed at a rate of 0.8704 mills for a period of four (4) years, 2026 through 2029 inclusive, for the purpose of providing funds for equipment, maintenance and improvements for the fire department?

Sands Township – Road Repair Operating Millage Renewal Shall the expired previous voted millage of two mills (\$2.0000 on each \$1,000 of taxable value) as reduced by the required millage roll back which last resulted in a levy of 1.7415 mills (\$1.7415 on each \$1,000.00 of taxable value) against all property in Sands Township, Marquette County, Michigan be renewed at a rate of 1.7415 mills for a period of four (4) years, 2026 through 2029 inclusive, for the purpose of providing funds for road repairs within Sands Township?

Wells Township – General Operating Renewal Shall the voters of Wells Township, Marquette County, Michigan approve the renewal of a levy of up to 1.4778 mils on valuation (approximately \$1.47 per \$1,000.00 of taxable value) for a period of 8 years, to commence in 2027, to be used for general operating expenses?
